# KINGSVILLE TOWNSHIP ORGANIZATIONAL MEETING January 1, 2025 – 12:00 pm.

The Kingsville Township organizational meeting called to order by Fiscal Officer Michael DeFazio, followed by the Pledge of Allegiance. The Fiscal Officer turned the meeting over to Jim Branch, Chairman.

**Election of Board Chairman:** Jim made a motion to elect Mike Cliff as Chairman of the Board for 2025. Motion seconded by Karl. Motion passed. Jim turned meeting over to 2025 Chairman Mike Cliff.

**Election of Board Vice – Chairman**: Jim made a motion to elect Karl as Vice Chairman of the Board for 2025. Motion seconded by Mike. Motion passed.

**Zoning Commission:** Jim made a motion to reappoint Mark Falke to the Zoning Commission for a five year term through 2029. Motion seconded by Mike. Motion passed.

**Zoning Board of Appeals:** Jim made a motion to reappoint Shawn Wasson to the Board of Zoning Appeals for a five year term through 2029. Motion seconded by Karl. Motion passed.

**Zoning Inspector:** Karl made a motion to reappoint Mike DeFazio as Zoning Inspector. Motion seconded by Jim. Motion passed.

## Zoning Fees:

Jim made a motion for no changes in fees for zoning in 2025. Motion seconded by Karl. Motion passed. The zoning fees for 2025:

\$35.00 Residential Accessory; \$100.00 Residential New Construction; \$200.00 Commercial New Construction; \$100.00 Commercial per sign; \$150.00 Residential Variance Hearing; \$250.00 Commercial Variance Hearing; \$500.00 Zoning Text or Map Amendment / Change; \$0.25 a copy fee per page for any requests, general or zoning.

**Cemetery Sexton:** Karl made a motion to reappoint Chris Bradek as Cemetery Sexton. Motion seconded by Jim. Motion passed.

**Cemetery Fees:** Chris presented new fees for Saturday burials. Chris recommended raising fees for: After 2:00 pm and Saturday burials for adult from \$550.00 to \$600.00; Infant to remain the same \$300.00; Ashes from \$300.00 to \$350.00.

Jim made a motion to approve the new fees for Saturday burials and continue the rest of the Cemetery fees from 2024. Motion seconded by Mike. Motion passed.

Foundations: \$30 per cubic foot

A resident has a legal physical address in Kingsville Township

Resident Veterans will receive 50% off all fees if a DD-214 is presented.

#### Foundations:

All monuments and stones will be set on a foundation. Foundations will be poured 8" larger than the base of the monument or stone, length and width and will be 36" deep.

The person who is ordering the foundation, including Veteran markers, shall pay the fee before the pouring.

Pouring will be done twice a year. Foundation orders and payments are due April 1st and September 1st.

Monument companies may dig, form, and pour their own foundations under the supervision and approval of the Sexton.

Mike made a motion to exit executive session. Motion seconded by Karl. On a Call of Roll: Mike Cliff – Yes, Karl Brunnel – Yes, Jim Branch – Yes. Motion passed.

Mike made a motion for no change to employee wages for 2025. Motion seconded by Karl. Motion passed.

Mike made a motion to set the Trustees and Fiscal Officers Salaries based on the Ohio Township Association's chart for 2025 which includes a 1.75% increase using the Township Budget bracket of \$750,000 to \$1,500,000. Motion seconded by Karl. Motion passed.

Karl made a motion to continue Fire Department Auxiliary pay of \$40.00 per call to be paid out monthly. Motion seconded by Mike. Motion passed.

Fiscal Officer presented **Resolution 2025-001** (2025 Revenue Budget) & **Resolution 2025-002** (2025 Temporary Appropriations) for approval.

**Resolution 2025-001**: To approve the **2025 Revenue Budget** in the amount **\$1,034,029.56**. Added to the 2024 Carryover Balance, which is **\$1,041,061.29** as of 12/31/2024, the Total Estimated Resources for 2025 are **\$2,075,090.85**.
